# O6 Sustainability and corporate social responsibility

#### **Business and infrastucture**

Moens Packaging is continuously proactive in engaging in energy-saving measures, as well as renewable energy sources. Some of our initiatives include

- We have 375 solar panels spread across our 3 sites.
- When necessaryThe electricity is supplemented with electricity from "Wase Wind" wherever possible. They supply 100% pure wind power and support several wind farms.
- In one of our sites, we use a battery to store renewable energy.
- We have light sensors in the different aisles in the warehouses, so the lights do not have to be on continuously.
- We have installed LED lighting in the warehouses.
- We use recycled paper in our business.
